 Must have a **Bachelor Degree in Law, Economics, Finance or STEM.**

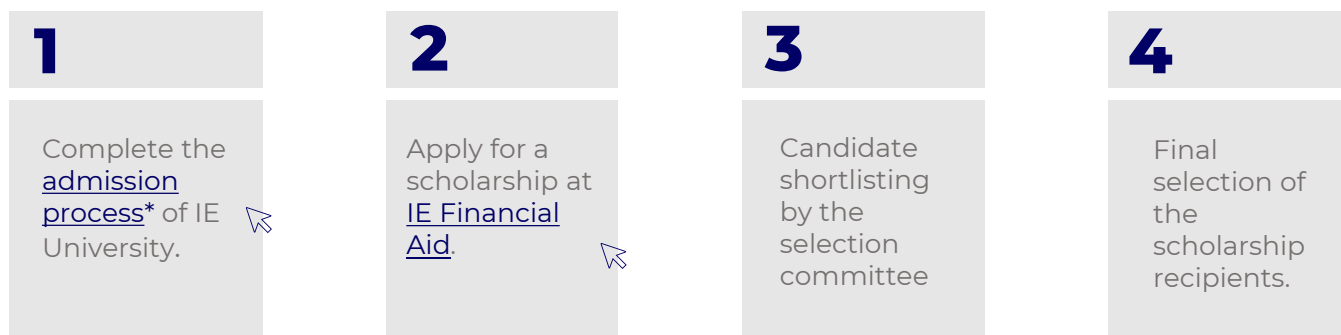
 Must have an **outstanding academic record.**

APPLICATION PROCESS



DEADLINE: 1st of May

***Attention:** The admissions process may take up to 4 weeks to reach a final decision. Therefore, it is recommended to begin all necessary steps at least 6 weeks before the indicated deadline. Steps 1 and 2 of the process must be initiated by the scholarship applicants. Steps 3 and 4 pertain to internal administrative processes.
