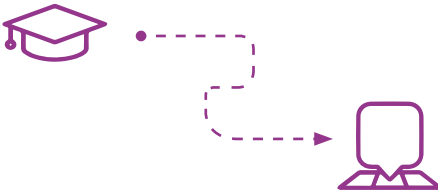

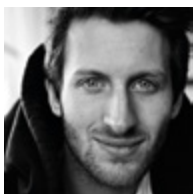

The program is centered on finance and the financial recruitment market, and covers key topics in today's finance industry, including FinTech, mergers & acquisitions, and private equity.

This program includes innovative learning processes using multimedia applications, an online investment role-playing game using the Bloomberg platform, Matlab (fixed income programming, financial modeling, and analysis) and Factset.

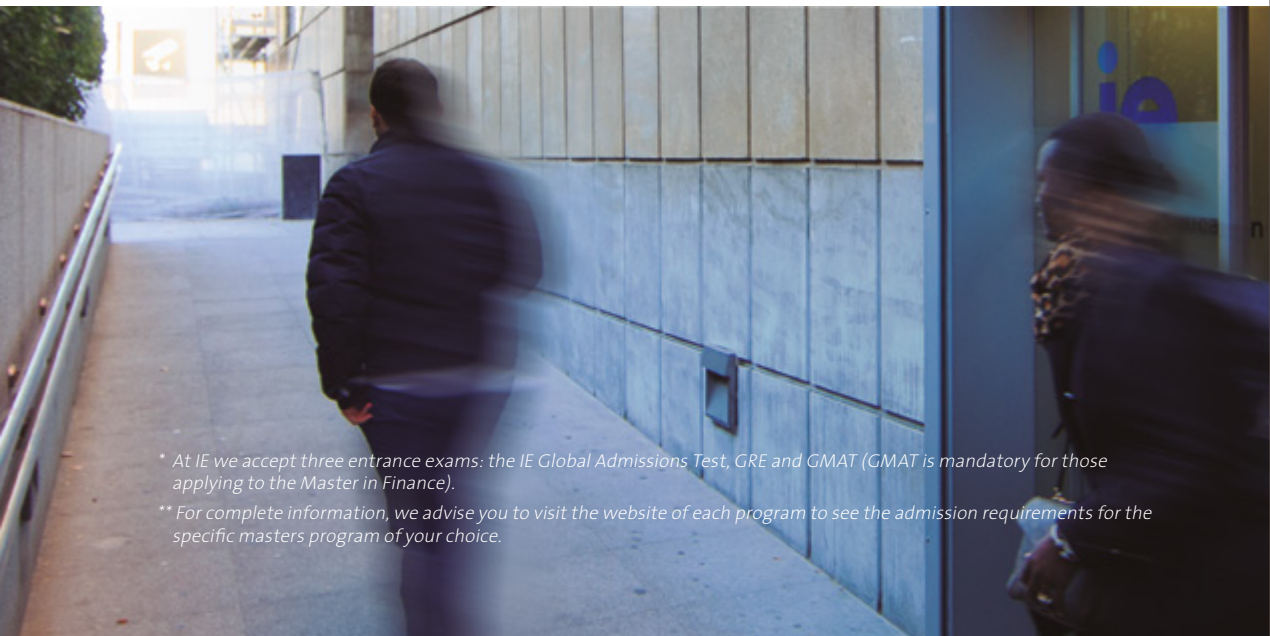
Admissions and Financial Aid

At IE, we seek dynamic, motivated, creative candidates with excellent professional and/or academic backgrounds who have the potential to develop the interpersonal and leadership skills demanded in today's top professionals.

To obtain a place on one of our masters programs, it is necessary to have completed undergraduate studies at an accredited university. The process may be initiated during the final year of your undergraduate studies.

IE offers a rolling admissions process. As such, there are no submission deadlines for any particular intake. However, given the limited number of places in the programs and the diverse student body, it is highly recommended you present your application several months prior to program commencement.

For those students wishing to study a program in a language which is not their native language, it will be necessary to include a language certificate.
